EXPECTATIONS
<b>Main Purpose:</b> The subject leader will take lead responsibility for providing leadership and management for History and Sociology to secure: <ul style="list-style-type: none"><li>• High-quality teaching</li><li>• Effective use of resources</li><li>• Improved standards of learning and achievement for all</li><li>• Maintain high expectations, motivating and inspiring students to learn, create and achieve as well as reflect on their own progress, professional and personal development.</li><li>• Maintain a purposeful, creative and positive working atmosphere in the classroom through the clear communication of academy expectations and consistent use of the academy Behaviour Policy.</li></ul> <p>The core purpose of a qualified teacher is to teach to the highest standards to ensure all students achieve their potential. The post holder fulfils their pastoral role through seeking to maximise students' self-esteem, motivation, aspiration and achievement and by being a Form Tutor. The Teacher Training Agency has defined the national professional standards for qualified teacher status and these form the content of this job description.</p>
DUTIES AND RESPONSIBILITIES
<b>Key Responsibilities</b> <ul style="list-style-type: none"><li>• Provide professional leadership to a team of teachers and support staff in the delivery of the full range of History and Sociology teaching from KS3 to KS5.</li><li>• Develop innovative approaches to the History and Sociology curriculum in order to ensure appropriate access and achievement for all students.</li><li>• Manage the department resources within the limits of the delegated budget and in accordance with the academy's financial procedures.</li><li>• As the academy expands you will ensure appropriate performance management arrangements are in place and maintained in the department and that a robust programme of professional development is designed and maintained (this to include provision for support staff and non-specialist teachers).</li><li>• As the academy expands robust procedures are put in place to monitor the quality of teaching and learning outcomes throughout the department.</li><li>• Contribute significantly to the school's planning (both short and long term) and provide leadership to whole school developments, as required.</li><li>• Lead all aspects of the History and Sociology curriculum to maximise student progress.</li><li>• Track progress regularly through lesson observations and work scrutiny.</li><li>• Represent the department at meetings with Governors, parents, inspectors and other schools when necessary.</li></ul>

- Demonstrate consistently the positive attitudes, values and behaviour which are expected of students and set high standards for students' learning, motivation, attendance, punctuality, submission of work and presentation of work and addressing non-compliance.
- Encourage students to take a responsible, conscientious and scholarly attitude to their own work, creativity and study.
- Have clear rules and routines for behaviour in classrooms, and take responsibility for promoting an excellent culture of learning both in classrooms and around the academy, in accordance with the academy's code of conduct/behaviour policy.
- Set and maintain high expectations of student behaviour and establish a framework for discipline with a range of strategies, using praise, sanctions and rewards consistently and fairly.
- Maintain good relationships with students, exercise appropriate authority and act decisively when necessary.
- Responsibility of Health and Safety/Risk Assessments.

### Leading the Curriculum

- Develop and review regularly the vision, aims and purpose for the subject area.
- Plan and teach great lessons in accordance with subject area programmes of study and examination specifications, ensuring all lessons are thoroughly prepared and intelligently structured, with clear aims and learning objectives to challenge every learner.
- Ensure the planned curriculum is effectively and consistently implemented across the academy.
- Make sure there is an effective system of assessment that oversees the progress of students to ensure the curriculum has a positive impact on students' learning.
- Take account of students' prior levels of achievement and use them to set targets for tracking, to secure excellent qualification outcomes for students.
- Attend parents' evenings according to the academy calendar to keep students' families and/or their carers informed about their progress.
- Have a clear understanding of the needs of all learners, including those with special educational needs; those of high ability; those with English as an additional language; those with disabilities; and be able to use and evaluate distinctive teaching approaches to engage and support them.

### Leading and Managing Staff

- As the academy expands, establish an effective team and hold regular meetings to keep staff informed on any developments or changes.
- Provide support to staff regarding teaching and learning, resources and planning in the subject area.
- Monitor teaching and learning by visiting lessons, scrutinising books, and talking with students to assess how well the subject area is being implemented and how well it is delivered across the academy.
- Provide feedback to staff based on the above observations to identify training needs and provide continuing professional development (CPD) in the subject area.
- Coach and model team teaching where possible.
- Liaise effectively with exam boards to ensure that teachers understand and are familiar with the syllabuses that are being delivered.
- Support teachers to make accurate assessments, manage internal and external moderation, and complete external moderation exercises.
- Take responsibility for performance management for your team, appraising staff in line with the school's appraisal policy.
- Contribute to timetabling and manage setting students into attainment groups.
- Maintain up to date professional subject knowledge, practical media production skills and a critical understanding of developments in the subject and curriculum areas, through personal study, creative practice and formal courses or training programmes.
- Participate in internal and external CPD activity necessary to update professional practice reflecting individual,

subject area or whole school development goals.

- To act at all times in accordance with the academy's Safeguarding, Equality and Diversity and Health and Safety Policies.

### **Knowledge and Understanding:**

- Have a secure knowledge and understanding of the concepts and skills in your specialist subject, at a standard equivalent to degree level to enable you to teach it confidently and accurately at KS3, KS4 and post-16.
- Have, for your specialist subject, where applicable, detailed knowledge and understanding of the National Curriculum programmes of study, level descriptions or end of key stage descriptions for KS3 and where applicable National Curriculum programmes of study for KS4;
- Be familiar, for your specialist subject, with the relevant KS4 and post-16 examination syllabuses and courses, including vocational courses;
- Understand, for your specialist subject, the framework of 14-19 qualifications and the routes of progression through it;
- Understand, for your specialist subject, progression from the KS2 programmes of study;
- Know and can teach the key skills required for current qualifications relevant to your specialist subject, for students aged 14-19 and understand the contribution that your specialist subject makes to the development of the key skills;
- Cope securely with subject-related questions which students raise;
- Be aware of recent inspection evidence and classroom-relevant research evidence on teaching secondary students in your specialist subject and use this to inform and improve your teaching;
- Know, for your specialist subject, students' most common misconceptions and mistakes;
- Understand how students' learning in the subject is affected by your physical, intellectual, emotional and social development;
- Have, for your specialist subject, a secure knowledge and understanding of the content specified in the ITT National Curriculum for Information and Communications Technology in subject teaching;
- Are familiar with subject-specific health and safety requirements, where relevant, and plan lessons to avoid potential hazards.

### **Planning:**

- Plan your teaching to achieve progression in students' learning through: identifying clear teaching objectives and content, appropriate to the subject matter and the students being taught, and specifying how these will be taught and assessed;
- Setting tasks for whole class, individual and group work, including homework, which challenge students and ensure high levels of student interest;
- Setting appropriate and demanding expectations for students' learning, motivation and presentation of work;
- Setting clear targets for students' learning, building on prior attainment and ensuring that students are aware of the substance and purpose of what they are asked to do;
- Identifying students who: Have special educational needs, including specific learning difficulties; Are very able
- Are not yet fluent in English. Knowing where to get help in order to give positive and targeted support.
- Provide clear structures for lessons, and for sequences of lessons, in the short, medium
- and longer term, which maintain pace, motivation and challenge for students;
- Make effective use of assessment information on students' attainment and progress in your teaching and in planning future lessons and sequences of lessons;
- Plan opportunities to contribute to students' personal, spiritual, moral, social and cultural development;
- Where applicable, ensure coverage of the relevant examination syllabuses and National Curriculum programmes of study.

### **Teaching and Class Management:**

- Ensure effective teaching of whole classes and of groups and individuals within the whole class setting, so that teaching objectives are met and best use is made of available teaching time;
- Set high expectations for students' behaviour, establishing and maintaining a good standard of discipline through well-focused teaching and through positive and productive relationships;
- Monitor and intervene when teaching to ensure sound learning and discipline;
- Establish a safe environment which supports learning and in which students feel secure and confident;
- Use teaching methods which sustain the momentum of students' work and keep all students engaged throughout;
- Stimulating intellectual curiosity, communicating enthusiasm for the subject being taught, fostering students' enthusiasm and maintaining students' motivation.
- Matching the approaches used to the subject matter and the students being taught;
- Structuring information well, including outlining content and aims, signalling and summarising key points as the lesson progresses;
- Clear presentation of content around a set of key ideas, using appropriate subject-specific vocabulary and well chosen illustrations and examples;
- Clear instruction and demonstration, and accurate well-paced explanation;
- Effective questioning which matches the pace and direction of the lesson and ensures that students take part;
- Careful attention to students' errors and misconceptions, and helping to remedy them;
- Listening carefully to students, analysing their responses and responding constructively in order to take students' learning forward;
- Selecting and making good use of textbooks, ICT and other learning resources which enable teaching objectives to be met;
- Providing opportunities for students to consolidate their knowledge and maximising opportunities, both in the classroom and through setting well-focused homework, to reinforce and develop what has been learnt;
- Exploiting opportunities to improve students' basic skills in literacy, numeracy and ICT, and the individual and collaborative study skills needed for effective learning, including information retrieval from library, texts and other sources;
- Exploiting opportunities to contribute to the quality of students' wider educational development, including their personal, spiritual, moral, social and cultural development;
- Setting high expectations for all students notwithstanding individual differences, including gender, and cultural and linguistic backgrounds;
- Providing opportunities to develop students' wider understanding by relating their learning to real and work-related examples;
- Are familiar with the Code of Practice on the identification and assessment of special educational needs and, as part of your responsibilities under the Code, implement and keep records on individual education plans (IEPs) for students at Stage 2 of the Code and above;
- Ensure that students acquire and consolidate knowledge, skills and understanding in
- the subject;
- Evaluate your own teaching critically and use this to improve your effectiveness.

### **Monitoring, Assessment, Recording, Reporting and Accountability:**

- Assess how well learning objectives have been achieved and use this assessment to improve specific aspects of teaching;
- Mark and monitor students' assigned classwork and homework, providing constructive oral and written feedback, and setting targets for students' progress;
- Assess and record each student's progress systematically, including through focused observation, questioning, testing and marking, and use these records to check that students have understood and completed the work set;

- Monitor strengths and weaknesses and use the information gained as a basis for purposeful intervention in students' learning;
- Check that students continue to make demonstrable progress in their acquisition of the knowledge, skills and understanding of the subject;
- Be familiar with the statutory assessment and reporting requirements and know how to prepare and present informative reports to parents;
- Where applicable, understand the expected demands of students in relation to each relevant level description or end of key stage description, and, in addition, for those of 11-16 or 18 and 14-19 courses, the demands of the syllabuses and course requirements for GCSE, other KS4 courses, and, where applicable, post-16 courses
- Where applicable, understand and know how to implement the assessment requirements of current qualifications for students aged 14-19;
- Recognise the level at which a student is achieving, and assess students consistently
- against attainment targets, where applicable, if necessary with guidance from an experienced teacher;
- Understand and know how national, local, comparative and school data, including National Curriculum test data, where applicable, can be used to set clear targets for students' achievement;
- Use different kinds of assessment appropriately for different purposes, including National Curriculum and other standardised tests, and baseline assessment where relevant.

### **Efficient and Effective Deployment of Resources:**

- Provide support with textbooks and library books in subject area.
- Create a safe, welcoming environment and take care of the classroom accommodation, ensuring classroom displays are stimulating, of high quality, and inspire curiosity in students.
- Audit, check and manage resources to ensure they are up to date and match pupil and curriculum needs.
- Manage the subject budget effectively to ensure resources add value and enhance the learning experience.

### **Other Professional Requirements:**

- Have a working knowledge and understanding of Teachers' professional duties as set out in the current School Teachers' Pay and Conditions document, issued under the School Teachers' Pay and Conditions Act 1991;
- Have a working knowledge and understanding of Teachers' legal liabilities and responsibilities relating to:
  - The Race Relations Act 1976
  - The Sex Discrimination Act 1975
  - Section 7 and 8 of the Health and Safety at Work etc Act 1974
  - Teachers' common law duty to ensure the students are healthy and safe on school premises and when leading activities off the school site, such as educational visits, school outings or field trips;
  - What is reasonable for the purposes of safeguarding or promoting children's welfare (Section 3(5) of the Children Act 1989);
  - The role of the education service in protecting children from abuse (currently set out in DfES Circular 10/95 and the Home Office, Department of Health, DfES and Welsh Office Guidance 'Working Together: A guide to arrangements for inter-agency cooperation for the protection of children from abuse 1991);
  - Appropriate physical contact with students (currently set out in DfES Circular 10/95);
  - Appropriate physical restraint of students (Section 4 of the Education Act 1997 and DFES Circular 9/94);
  - Detention of students on disciplinary grounds (Section 5 of the Education Act 1997);
- Set a good example to the students you teach, through your presentation and personal and professional conduct;
- Understand the need to take responsibility for your own professional development and to keep up to date with research and developments in pedagogy and in the subjects you teach
- Understand your professional responsibilities in relation to school policies and practices, including those concerned with pastoral and personal safety matters, including bullying.
- Recognise that learning takes place inside and outside the school context, and understand the need to liaise

effectively with parents and other carers and with agencies with responsibility for students' education and welfare.

- Are aware of the role and purpose of school Governing Bodies.

### **Safeguarding:**

- Work in line with statutory safeguarding guidance (e.g. Keeping Children Safe in Education, Prevent) and our safeguarding and child protection policies
- Be alert to when persistent absence becomes a safeguarding concern and early help may be required
- Work with the designated safeguarding lead (DSL) to promote the best interests of pupils, including sharing concerns where necessary
- Promote the safeguarding of all pupils in the school
